

SUSTAINABLE PROCUREMENT POLICY

All information on planned and ongoing procurement is posted on the web portal for public procurement in the Republic of Kazakhstan goszakup.gov.kz.

All public procurements are carried out in electronic form, in accordance with the legislation of the Republic of Kazakhstan on public procurement, and in compliance with the following principles of public procurement:

- 1) optimal and efficient spending of money used for public procurement;
- 2) providing potential suppliers with equal opportunities to participate in the public procurement procedure, except for the cases provided for by the Law of the Republic of Kazakhstan "On Public Procurement";
- 3) fair competition among potential suppliers, prevention of collusion between procurement participants;
- 4) openness and transparency of the public procurement process, including compliance with the legal rights of suppliers to trade secrets (before summing up the results of public procurement);
- 5 providing support to domestic producers of goods, as well as domestic suppliers of works and services, to the extent that this does not contradict international treaties ratified by the Republic of Kazakhstan;
 - 6) responsibility of participants in public procurement;
 - 7) prevention of corruption manifestations;
 - 8) acquisition of innovative and high-tech goods, works, services;
 - 9) observance of the rights to intellectual property objects contained in the purchased goods.

To implement the 5 principles, a number of goods, works, and services are purchased from domestic manufacturers as well as from public associations of persons with disabilities of the Republic of Kazakhstan and organizations created by public associations of persons with disabilities of the Republic of Kazakhstan.

1. The list of goods, works, and services purchased only from suppliers who are in the register of domestic manufacturers and have an Industrial Certificate issued by the National Chamber of Entrepreneurs of the Republic of Kazakhstan "Atameken":

Goods belonging to the categories (according to the classifier of informatization objects) of software and products of the electronic industry, included in the register of trusted software and products of the electronic industry, and information and communication services for the temporary use of these goods.

- 2. The list of certain types of goods purchased from public associations of persons with disabilities of the Republic of Kazakhstan and organizations created by public associations of persons with disabilities of the Republic of Kazakhstan that produce and (or) supply goods:
- 1) bed linen of all kinds, a blanket, mattresses, bedspreads, various pillows, towels, napkins, bed covers, mattress covers, diapers;
- 2) padded jacket, insulated padded trousers, heat-protective suit, insulated semi-overalls, insulated vest, insulated jacket, camouflage field suit, trousers;
- 3) cotton work suit, cotton field suit, camouflage field jacket, welder suit, accumulator suit, work overalls;
 - 4) a chef's uniform, a baker's suit, and a variety of hats;
- 5) a variety of gowns, aprons, uniforms, signal vests, surgical suits, cotton shoe covers, production and housekeeping uniforms, a blanket;
 - 6) a variety of pajamas, men's underwear, shorts, footcloths, different shirts, different shirts;
 - 7) a variety of kerchiefs, handkerchief, collar, mittens;

- 8) curtains, canopies, and a variety of bags;
- 9) folders, envelopes, folders for papers, rulers;
- 10) packing boxes, archival boxes;
- 11) joinery;
- 12) furniture.
- 2. Manufactured and (or) supplied goods:
- 1) typhlotechnology tools;
- 2) special vehicles;
- 3) mandatory hygiene products.
- 3. The list of certain types of work purchased from public associations of persons with disabilities of the Republic of Kazakhstan and organizations created by public associations of persons with disabilities of the Republic of Kazakhstan that perform the work:

landscaping.

- 4. List of certain types of services purchased from public associations of persons with disabilities of the Republic of Kazakhstan and organizations established by public associations of persons with disabilities of the Republic of Kazakhstan that provide services:
- 1) supply, assembly, repair, and maintenance of rehabilitation equipment for persons with disabilities (crutches, canes, walkers, lifting devices and mechanisms, television and radio equipment);
 - 2) repair and maintenance of vehicles for persons with disabilities;
 - 3) organization of recreation and sanatorium-resort facilities for persons with disabilities;
 - 4) cleaning of premises and territories, cleaning services;
 - 5) beautification, landscaping;
 - 6) printing services;
 - 7) laundry services.
